Visit Details: (Additional details can be added by mutual agreement.) Santa is available on site in full costume at the dates/times listed above to visit with clients and be available for family portraits. Host/Photographer agrees to provide a sturdy, comfortable chair for Santa when seated on set and a secure, comfortable, separate break area when not on set. All photographic equipment, props, backdrops, etc. are the responsibility of the studio/photographer. Any prizes, gifts, or giveaways to be handed out by Santa during the event are to be provided by the host. All images are the property of the host photographer/studio. A limited model release is granted for use of images with Santa as part of a private retail portrait package; on line or print promotion for host studio/photographer; or photographic competition. A secondary model release for publication of images for 3rd party commercial use or any use that implies the endorsement by Santa of any product or viewpoint through either print or electronic media requires additional agreement. Editing, altering, or distorting Santa's image is to be limited to accepted aesthetic or composition purposes and must not result in the image of Santa in a manner that is defamatory or inconsistent with traditional perceptions or expectations.

Final payment (*including any unscheduled additional time) is due in full upon completion of services. *Unscheduled additional time (if necessary and available) is calculated at \$60 per 1/2 hour. Signatures below constitutes acceptance of terms as outlined. This tentatively secures the date until reserved with retainer. (Unless waived)

CANCELLATION POLICY:

- ❖ Cancellation 28 days or more prior: 75% of retainer refunded
- ❖ Cancellation 14-27 days prior: Retainer refunded only if scheduled date/time can be re-booked
- ❖ Late Cancellation (less than 14 days prior) Balance of fee for 'Total Time Reserved' is due, unless date can be re-booked
- ❖ For Christmas Eve Visits or events booked less than seven days in advance, pre-payment is required in full

If host decides not to have a Santa Claus at the event, or needs to cancel the booking due to conflicts with the date/time reserved, refunds are only eligible as listed above. For all late cancellations by host, including cancellations due to inclement weather; fees for total time reserved (minus retainer) is still due within 10 days, unless date/times can be re-booked. Visits requiring advance payment in full are not eligible for refund unless date/time is re-booked. In the unlikely event 'Santa' must cancel and is unable to reschedule, his liability is limited to return of any pre-payment.
